1. Push carts are required to abide by HarbourFront Centre's operational hours from 10am to 10pm daily, unless otherwise advised by push cart tenant at least 3 days in advance.
2. For level 1 push carts, monthly rental will be at S\$3600 (subject to GST).
3. For level 2 push carts, monthly rental will be at S\$2000 and \$2300 (subject to GST).
4. For level 3 push carts, monthly rental will be \$1,800 (subject to GST).
5. There will also be a one-time security deposit of one month rental required for all push carts, which will be refundable upon end of lease.
6. The merchandise sold must not conflict with those of the existing tenants in HarbourFront Centre.
7. All application of push carts will be subjected to management's approval.
8. For push carts without printed receipts, shoppers are not entitled to redeem for any lucky draws/contests or car parking redemption programmes organized by the HarbourFront Centre unless the push cart vendors provide printed receipts.
