ISSUE AND LISTING OF NEW UNITS UNDER THE DISTRIBUTION REINVESTMENT PLAN**

Further to the announcements dated 24 October 2023, 1 November 2023 and 8 November 2023, Mapletree Logistics Trust Management Ltd., as manager (the “**Manager**”) of Mapletree Logistics Trust (“**MLT**”), wishes to announce that it has issued 15,053,070 new units in MLT (“**Units**”) at an issue price of S\$1.437 per Unit pursuant to MLT’s distribution reinvestment plan (“**DRP**”) in respect of MLT’s distribution for the period from 1 July 2023 to 30 September 2023 (the “**2Q FY23/24 Distribution**”) on 19 December 2023.

The new Units will be credited by 19 December 2023 to securities accounts of MLT unitholders (“Unitholders”) who have elected to participate in the DRP. The new Units will commence trading on the Main Board of Singapore Exchange Securities Trading Limited at 9.00 a.m. on 19 December 2023.

The new Units will rank pari passu in all respects with the existing Units.

Following the issuance of the new Units, the total number of MLT Units has increased from 4,966,805,650 to 4,981,858,720.

Unitholders who did not elect or partially elected to participate in the DRP and overseas Unitholders who did not provide registered mailing addresses in Singapore to The Central Depository (Pte) Limited, will receive their respective entitlements to the 2Q FY23/24 Distribution in cash on 19 December 2023.
