However, Temasek is filing this notification form to report a change in deemed interest from 31.82% to 32.11% in MIT as a result of the acquisition of an aggregate of 9,665,694 voting units of MIT by DBS Bank Ltd. ("DBS Bank"), Mapletree Dextra Pte. Ltd. (Mapletree Dextra") and Mapletree Industrial Trust Management Ltd ("MITM") as a result of their participation in the Distribution Reinvestment Plan for the period ended 31 March 2014, on 4 June 2014 (the "Transaction").

The filing of Temasek's deemed interest arises from the aggregation of the deemed interest held by DBS Group Holdings Ltd ("DBSH") and Mapletree Investments Pte Ltd ("MIPL").
