

## **ANNOUNCEMENT**

### **ISSUE AND LISTING OF NEW UNITS UNDER THE DISTRIBUTION REINVESTMENT PLAN**

*3 June 2015* - Mapletree Industrial Trust Management Ltd., as manager (the “Manager”) of Mapletree Industrial Trust (“MIT”), wishes to announce that it will issue 13,404,138 new units in MIT (“New Units”) at an issue price of S\$1.5761 per Unit pursuant to MIT’s distribution reinvestment plan (“DRP”) in respect of MIT’s distribution for the Fourth Quarter Financial Year 2014/2015 from 1 January 2015 to 31 March 2015 (the “4QFY14/15 Distribution”) on 4 June 2015.

The New Units will be credited by 4 June 2015 to securities accounts of MIT unitholders (“Unitholders”) who have elected to participate in the DRP. The New Units will commence trading on the Main Board of Singapore Exchange Securities Trading Limited (“SGX-ST”) at 9.00 a.m. on 4 June 2015.

The new Units will rank *pari passu* in all respects with the existing Units.

Following the issuance of the New Units, the total number of MIT Units in issue has increased from 1,747,331,556 to 1,760,735,694.

Unitholders who did not elect or partially elected to participate in the DRP and overseas Unitholders who did not provide registered addresses in Singapore to The Central Depository (Pte) Limited, will receive their respective entitlements to the 4QFY14/15 Distribution in cash on 4 June 2015.
