## **ANNOUNCEMENT**

## DISCLOSURE PURSUANT TO RULE 704(31) OF THE LISTING MANUAL

28 October 2011 – Pursuant to the newly promulgated Rule 704(31) of the Listing Manual of the Singapore Exchange Securities Trading Limited, which came into effect on 29 September 2011, Mapletree Logistics Trust Management Ltd. ("MLTM"), as manager of Mapletree Logistics Trust ("MapletreeLog"), wishes to make the following disclosure.

MapletreeLog<sup>1</sup> and its subsidiaries (the "Group" or the "Borrowers") have existing loan facilities and medium term notes issued (the "Debt Facilities") that contain conditions restricting a change in the manager and/or a change in control of the manager of MapletreeLog. The aggregate Debt Facilities amount to Singapore Dollar equivalent of S\$1,624mil; of which S\$1,329mil is outstanding as at 28 October 2011. These conditions ("Conditions") require that MLTM shall remain as the manager of MapletreeLog; and/or the manager of MapletreeLog shall remain a subsidiary, whether directly or indirectly, whollyowned or majority-owned, of Mapletree Investments Pte Ltd, the sponsor of MapletreeLog.

In the event that any of the Conditions is not met, the lender(s) and the note-holders (as the case may be) may cancel the available commitment under the loan facilities or the notes issued and the Borrowers shall pay an amount equal to the aggregate of the principal amount outstanding under the Debt Facilities together with all accrued interest and other amounts outstanding within a stipulated time period.

As of the date of announcement, there has not been any breach of the Conditions.
