#### **ANNOUNCEMENT**

### NOTICE OF BOOKS CLOSURE AND DISTRIBUTION PAYMENT DATE

NOTICE IS HEREBY GIVEN that the Transfer Books and Register of Unitholders of Mapletree Logistics Trust ("MLT") will be closed at 5.00 pm on Monday 29 October 2012 for the purpose of determining unitholders' entitlements to MLT's distribution. MLT has announced a distribution of 1.71 cents per unit for the period from 1 July 2012 to 30 September 2012. The distribution of 1.71 cents per unit comprises a taxable income component of 1.05 cents per unit, a tax-exempt income component of 0.27 cents per unit and a capital component of 0.39 cents per unit.

Unitholders whose securities accounts with The Central Depository (Pte) Limited are credited with units in MLT as at 5.00 pm on 29 October 2012 will be entitled to the distribution that will be paid on **Thursday 29 November 2012**.

# **Declaration for Singapore Tax Purposes**

- The tax-exempt income component of the distribution is exempt from tax in the hands of all unitholders. No tax will be deducted at source from this component.
- The capital component of the distribution is treated as a return of capital for Singapore income tax purposes. No tax will be deducted at source from this component.
- Tax will be deducted at source from the taxable income component in certain circumstances. The following paragraphs describe the circumstances in which tax will or will not be deducted from the taxable income component of the distribution.
- The following categories of unitholders will receive a gross distribution (i.e. no tax will be deducted from it):-
  - (a) unitholders who are individuals and who hold the units either in their sole names or jointly with other individuals;
  - (b) unitholders which are companies incorporated and tax resident in Singapore;
  - (c) unitholders which are Singapore branches of foreign companies that have obtained specific approval from the Inland Revenue Authority of Singapore to receive the distribution from MLT without deduction of tax; and
  - (d) unitholders which are non-corporate entities (excluding partnerships) constituted or registered in Singapore.
- To receive a gross distribution, unitholders in categories (b) to (d) above must complete a prescribed form the "Declaration for Singapore Tax Purposes Form" ("Form A").

- These categories of unitholders, unless they are exempt from tax because of their own circumstances, will have to pay income tax subsequently at their own applicable tax rates.
- Unitholders in category (a) are not required to submit any form. The gross distribution received by these unitholders (irrespective of their tax residence status) is exempt from tax if it is not derived through a partnership in Singapore or from the carrying on of a trade, business or profession.
- Tax at the reduced rate of 10% will be deducted from the distribution made to foreign non-individual unitholders. A foreign non-individual unitholder is one (other than an individual) who is not a resident of Singapore for income tax purposes and:-
  - (a) who does not have a permanent establishment in Singapore; or
  - (b) who carries on any operation in Singapore through a permanent establishment in Singapore, where the funds used to acquire the units in MLT are not obtained from that operation.
- 9 To receive the distribution net of tax deducted at 10%, foreign non-individual unitholders are required to complete Form A.
- Beneficial owners of units in MLT who hold their units through depository agents will receive:-
  - (a) gross distribution if they are persons described in categories (a) to (d) under Paragraph 4 above; and
  - (b) distribution net of tax deducted at 10% if they are foreign non-individuals described in Paragraph 8 above.
- To receive gross distribution and distribution net of tax deducted at 10%, depository agents are required to complete the "Declaration by Depository Agents for Singapore Tax Purposes Form" ("Form B") and its annexes.
- Form A and Form B (and its annexes) will be sent to unitholders and depository agents respectively, by MLT's Unit Registrar, Boardroom Corporate & Advisory Services Pte. Ltd., on or around Friday 2 November 2012.
- Unitholders (Form A) and the depository agents (Form B and its annexes) will have to complete the forms legibly and send it to the Unit Registrar such that they are received by **5.00 pm** on **Thursday 15 November 2012**. Failure to comply with any of these requirements will render Form A and Form B invalid and the trustee and the Manager of MLT will be obliged to deduct tax at the rate of 17% from the distribution.
- Unitholders who hold units under the Central Provident Fund Investment Scheme ("CPFIS") and the Supplementary Retirement Scheme ("SRS") do not have to return any form. They will receive gross distribution.

### **Distribution Reinvestment Plan**

As announced by Mapletree Logistics Trust Management Ltd., in its capacity as manager of MLT (the "Manager") on 18 October 2012, the Manager will apply the Distribution Reinvestment Plan ("DRP") to the 2Q FY12/13 Distribution. The DRP will enable unitholders of MLT to acquire additional units in MLT without having to incur transaction or other related costs by electing to receive all or part of the distributions in the form of units instead of cash.

The tax treatment as described above will apply for unitholders electing to receive distributions in units. Where deduction of income tax is applicable and the unitholders elect to receive the distributions in units, the number of units to be allotted under the DRP will be computed based on the distributions net of tax deducted.

Unitholders who wish to participate in the DRP will have to complete the Notice of Election and send it to the Unit Registrar such that it is received by **5.00 pm** on **Thursday 15 November 2012**. Unitholders who do not wish to participate in the DRP need not complete the Notice of Election. Such unitholders will receive their distributions in cash.

#### **Declaration in Income Tax Return**

This distribution is considered as income for the year 2013. Beneficial owners of the distribution, other than those who are exempt from tax on the distribution or who are entitled to the reduced tax rate of 10%, are required to declare the gross amount of the taxable income component of the distribution (regardless whether the distribution is paid in cash or in the form of units) as taxable income in their Singapore income tax return for the year of assessment 2014.

### **Important Reminder**

Unitholders and depository agents must complete and return the "Declaration for Singapore Tax Purposes Form A and Form B (and its annexes)" and Notice of Election, respectively to the Unit Registrar's office by **5.00 pm** on **Thursday 15 November 2012** in order to receive the distribution either at gross or at net (after deduction of tax at 10%) as described above.
