PAYMENT OF ACQUISITION FEE BY WAY OF NEW UNITS IN MAPLETREE LOGISTICS TRUST

Mapletree Logistics Trust Management Ltd., as manager (the “Manager”) of Mapletree Logistics Trust (“MLT”) wishes to announce that 200,539 new units in MLT (“Units”) have been issued today to the Manager at S\$1.1419 per Unit.

Following this issuance, the Manager holds an aggregate of 3,914,395 units, approximately 0.2% of the total number of units in issue of 2,432,009,994.
