ISSUE PRICE OF NEW UNITS TO BE ISSUED PURSUANT TO THE DISTRIBUTION REINVESTMENT PLAN FOR THE 4Q FY13/14 DISTRIBUTION

Further to the announcement dated 21 April 2014 by Mapletree Logistics Trust Management Ltd., as manager (the "Manager") of Mapletree Logistics Trust ("MLT") in relation to the application of the distribution reinvestment plan ("DRP") to MLT's distribution for the three months ended 31 March 2014 (the "4Q FY13/14 Distribution"), the Manager wishes to announce that the issue price of the new units in MLT ("Units") to be issued under the DRP is S\$1.0671 per Unit.

The issue price represents a 1%¹ discount to the adjusted volume-weighted average traded price² per Unit ("adjusted VWAP") for all trades on Singapore Exchange Securities Trading Limited (the "SGX-ST") during the period of 10 market days prior to and ending on the Books Closure Date ("BCD") on 29 April 2014.

The notice of election is expected to be despatched to all Eligible Unitholders³ on 6 May 2014 for which an announcement will be issued accordingly.

The issue price represents effectively a 2% discount to the volume-weighted average traded price per Unit for all trades on the SGX-ST during the period of 10 market days prior to and ending on the BCD.

The adjusted VWAP is computed based on the volume-weighted average traded price per Unit for all trades on the SGX-ST for each of the market days during the period of 10 market days prior to and ending on the BCD and subtracting the 4Q FY13/14 Distribution of 1.89 cents per Unit for each of the market days prior to the first day of "ex-distribution" trading.
