COMPLETION OF ACQUISITION OF PROPERTY IN ISKANDAR MALAYSIA

Further to its press release dated 10 January 2014, Mapletree Logistics Trust Management Ltd., as manager of Mapletree Logistics Trust ("MLT"), wishes to announce that the acquisition of the industrial warehouse in Iskandar Malaysia for a purchase consideration of MYR 88.5 million (~S\$34.3 million¹) has been completed today.

With this acquisition, MLT's portfolio has increased to 112 properties comprising 52 properties in Singapore, 22 in Japan, 8 in Hong Kong, 8 in South Korea, 7 in China, 14 in Malaysia and 1 in Vietnam. The total book value of these properties is approximately S\$4.27 billion².
