ISSUE AND LISTING OF NEW UNITS UNDER THE DISTRIBUTION REINVESTMENT PLAN

Mapletree Logistics Trust Management Ltd., as manager (the “Manager”) of Mapletree Logistics Trust (“MLT”), wishes to announce that it will issue 2,392,746 new units in MLT (“Units”) at an issue price of S\$1.0066 per Unit pursuant to MLT’s distribution reinvestment plan (“DRP”) in respect of MLT’s distribution for the three months ended 31 March 2016 (the “4Q FY15/16 Distribution”) on 9 June 2016.

The new Units will be credited by 9 June 2016 to securities accounts of MLT unitholders (“Unitholders”) who have elected to participate in the DRP. The new Units will commence trading on the Main Board of Singapore Exchange Securities Trading Limited at 9.00 a.m. on 9 June 2016.

The new Units will rank *pari passu* in all respects with the existing Units.

Following the issuance of the new Units, the total number of MLT Units has increased from 2,490,121,690 to 2,492,514,436.

Unitholders who did not elect or partially elected to participate in the DRP and overseas Unitholders who did not provide registered mailing addresses in Singapore to The Central Depository (Pte) Limited, will receive their respective entitlements to the 4Q FY15/16 Distribution in cash on 9 June 2016.
