Temasek's deemed interest arises from the aggregation of the interests of MIPL, DBSH and Fullerton.

(i) Mapletree Logistics Properties Pte. Ltd. ("MLP") holds 3.761% of Units. (ii) Mangrove Pte. Ltd. ("Mangrove") holds 3.761% of Units. (iii) Mulberry Pte. Ltd. ("Mulberry") holds 16.324% of Units. (iv) Meranti Investments Pte. Ltd. ("Meranti") holds 7.733% of Units. (v) MLP, Mangrove, Mulberry and Meranti are wholly owned subsidiaries of MIPL.
