COMPLETION OF DIVESTMENT OF A PROPERTY IN JAPAN

Further to its press release dated 1 September 2023, Mapletree Logistics Trust Management Ltd., as Manager of Mapletree Logistics Trust (“MLT”), wishes to announce that the divestment of Moriya Centre has been completed today.

Following this divestment, MLT’s portfolio stands at 189 properties, comprising 51 properties in Singapore, 14 in Australia, 43 in China, 9 in Hong Kong SAR, 2 in India, 24 in Japan, 15 in Malaysia, 21 in South Korea and 10 in Vietnam. The total value of assets under management is S\$13.4 billion¹.
