MAPLETREELOG INCLUDED IN GPR 250 INDEX SERIES

Singapore, 2 October 2006 – Mapletree Logistics Trust Management Ltd. ("MLTM"), the manager of Mapletree Logistics Trust ("MapletreeLog"), is pleased to announce that the Trust has been included as one of the constituent stocks of the GPR 250 Index and GPR 250 REIT Index with effect from 1 October 2006.

The GPR 250 Index is a free float weighted index that tracks the performances of 250 most liquid property companies worldwide as measured by the highest twelve-month trading volume in U.S. dollars. It is a total return index and is calculated on a daily basis. Re-weighting of the index constituents is done on a quarterly basis.

The GPR 250 REIT Index is a subset of the GPR 250 Index and the selection criteria, calculations, periodic adjustments and all other fundamentals are exactly the same as that for GPR 250 Index. Only companies that are organized as a REIT or similar structure are included in the GPR 250 REIT Index.

Currently, of the 250 constituent companies in the GPR 250 Index, 116 are from North America, 61 from Europe, 51 from Asia, 18 from Oceania and 4 from Africa. Only 174 of the 250 companies included in the GPR 250 Index are included in the subset GPR 250 REIT Index. Of these 174 companies, 114 are from North America, 13 from Europe, 26 from Asia, 18 from Oceania and 3 from Africa. MapletreeLog is one of five Singapore REITs that are included in the GPR 250 and GPR 250 REIT indices.

To qualify for inclusion in the indices, companies must have a free float market cap of at least US\$50 million and must derive at least 75% of their operational profits from real estate activities. The inception of the indices dates back to 1989.

Mr. Chua Tiow Chye, Chief Executive Office of MLTM said, "We are very pleased to be included in these global property indices. This is a positive development as our unitholder base expands and becomes an increasingly global one."

Both the GPR 250 Index and the GPR 250 REIT Index are published by Netherlands-based Global Property Research B.V. ("GPR"). Established in 1996, GPR is part of Kempen & Co, an independent Dutch merchant bank and has a clear focus on real estate securities. GPR's client base consists of institutional investors, fund managers and other professional investment parties in the global listed property sector. More than US\$90 billion of assets are managed with GPR indices.

"Inclusion in established indices such as GPR 250 will help to raise the global profile of MapletreeLog. As fund managers and other professional investment entities monitor and benchmark global indices, it will help to keep MapletreeLog on their radar screens," Mr Chua added.

According to GPR, 86% of worldwide specialized fund managers in property stocks use GPR for their benchmarking purposes as at September 2006. The indices are distributed via Bloomberg, Reuters, Datastream, FactSet, Wilshire, EcoWin, Rimes, Capco, FinInfo, Markit Equities, Vestek and GPR's website, www.propertyshares.com.
